The Indian Affairs Department welcomes new staff: General Counsel, Carrie Frias, Policy, Legislative Affairs and Communications Bureau Chief, Keegan King, and Senior Policy Analyst, Stephanie M. Salazar.

Carrie Frias serves as the General Counsel for the Indian Affairs department, prior to joining IAD Carrie worked as the Chief General Counsel for the Pueblo of Pojoaque. Carrie worked at the Pueblo for five years and managed the Pueblo's in-house legal department of four attorneys. Previously Carrie lobbied on behalf of tribes in Washington D.C. at Anderson Indian Law, where she assisted in passing the tribal provisions in VAWA which returned some criminal jurisdiction to tribes to prosecute domestic violence crimes on their reservations. Before relocating to Washington D.C. Carrie served as a prosecutor at the Hopi tribe and the Pueblo of Laguna. Carrie also worked as a public defender and prosecutor for the State of New Mexico. Carrie clerked for the Navajo Nation Supreme Court while at the University of New Mexico School of Law. She is passionate about defending the rights of Native women and children who are victims of crime.

Keegan King serves as the Policy, Legislative Affairs and Communication Bureau Chief at the Indian Affairs Department. Keegan is an enrolled tribal member from the Pueblo of Acoma. Prior to joining New Mexico IAD, he worked as a consultant specializing in policy development and communication strategy. His experience includes campaign organizing in tribal communities, building broad coalitions to achieve policy outcomes and organizing with communities-of-color throughout the country.

Stephanie M. Salazar (Diné) joins the Indian Affairs Department following her work as a policy analyst for the 2019 legislative session. Prior to her legislative work, Stephanie served as the Tribal Prosecutor at the Pueblo of Isleta. She also worked for the American Indian Law Center, Inc. where she was part of a team that conducted tribal court assessments for tribes in New Mexico and California. She earned her Bachelor of Arts in Native American Studies and Political Science from the University of New Mexico and she obtained a Juris Doctorate with a certificate in Indian Law from the University of New Mexico School of Law. She is currently a member of the New Mexico State Bar.

## ***Administrative Services Division (ASD) Unit:***

*Special Projects* - During the 2019 New Mexico Legislative Session, the New Mexico Indian Affairs Department (IAD) received a General Fund Appropriation to support special projects in Fiscal Year 2020 that benefit NM tribal communities. From this appropriation, the Department has **\$603,600** available for projects that identify and address a need of tribal communities across the State of New Mexico. Projects should be focused on providing direct services which will benefit the Native American people of the state. The project should identify and address a direct need in tribal communities.

*Tobacco Cessation & Prevention Projects (TCPP)* - IAD also received an Interagency Transfer Fund Appropriation from the Tobacco Settlement Fund to support Tobacco Cessation & Prevention Projects in the State during the 2020 Fiscal Year (July 1, 2019- June 30, 2020). The Department has **\$249,300** available for tribal-specific tobacco cessation and prevention initiatives. The Department will consider funding projects that focus on building tribal capacity to implement culturally appropriate tobacco cessation and prevention initiatives that recognize the unique ceremonial uses of tobacco while reducing the use of commercial tobacco and its harmful effects.

*Tribal Infrastructure Fund (TIF)* - The IAD was invited to attend the Littlewater Chapter Springs Project Line “Meter Installation” Celebration on May 15, 2019. The first residence that received the meter installation was Leo Thompson, Grace Livingston, Rebekah J. Martin, James Enrico, Lucille Yazzie, Peterson Enrico, Lesley Cadman and Hebert Enrico, Jr.. The community members were very appreciative and told stories of how long they had to wait to receive electricity. “I have waited since 1974 to receive electricity and my parents at the time were still alive, and to receive electricity today, I know my mother knows that we received electricity” said Grace Livingston. Ms. Livingston did the honors of turning on her meter and her lights to home came on, and now she has plans to improve her home. In total, eight (8) homes were provide with meter installation and Littlewater Chapter has reached 90% of homes that now have electricity. Genevieve Castillo, Community Service Coordinator was thankful to the community, Continental Divide Electric Company, and the New Mexico Indian Affairs Department.

## ***Policy Unit:***

During the month of April, the IAD Policy Unit was busy creating new research documents, following up on legislated tasks from the just-adjourned legislative session, and creating a foundation for the upcoming State-Tribal Leaders' Summit in May. We are following broad topics of energy, education, cultural resource protection, behavioral health, economic development, to name a few. In addition, at every opportunity we are learning more about the Indian nations, tribes and pueblos that we serve and your legislative and community priorities.

Also, a friendly reminder that The 2019 New Mexico State Legislature New Mexico Indian Affairs Department Policy Unit Summary is now available on our website.

The Summary provides a narrative of legislation that impacts New Mexico's Indian nations, tribes, and pueblos in the area of education, natural resources energy, cultural and community resources, health, criminal justice, veterans, and governance. With over 1,600 bills introduced in the 2019 legislation, the Indian Affairs Department policy unit conducted analysis of 85 bills for the Legislative Finance Committee and tracked more than 100 bills related to Indian communities. The summary reflects legislation signed by Governor Michelle Lujan Grisham, legislation that passed through the Legislature but not signed by the Governor, and legislation that either died in committee or on the senate/ house floor.
