Project Awards and Closeouts for FY 2018

The New Mexico Indian Affairs Department (IAD) successfully closed out forty-four (44) Tribal Infrastructure Fund Projects and seventy-two (72) Capital Outlay Projects. With continued communication between the nations, tribes and pueblos, IAD has had the highest documented year of project closeouts. IAD is committed to continuing to strengthen tribal and state relations and address the challenges that face our tribal communities and we hope the hard work and dedication continues as we move forward. Below is a brief description of closed projects and award listing.

Awarded Projects - TIF

During FY 2018 the TIF received \$8,831,925.00 in Severance Tax Bonds to fund financial assistance to tribes for qualified projects. Per the [Tribal Infrastructure Act of 2005](#), the primary purposes of the Act are threefold: one, to ensure adequate financial resources for infrastructure development for tribal communities; two, to provide for the planning and development of infrastructure in an efficient and cost-effective manner; and three, to develop infrastructure in tribal communities to improve the quality of life and encourage economic development. The TIF portal usually opens in February of each year and remains open for 30 days.

FY 2018 Awarded Projects - Capital Outlay

Capital Outlay is authorized by the Legislature and generally is nonrecurring – one-time – money. Capital Outlay funds are used to build, improve or equip physical property that will be used by the public. Upon the conclusion of the legislative session, the Governor of New Mexico has 20 days to either approve or line item veto capital outlay projects. The IAD will immediately notify the tribal entity/organization of the capital outlay projects appropriated to their community through an award letter for both Severance Tax Bond and General Fund appropriations. IAD received an appropriation from the Tobacco Settlement Revenue Oversight Committee in the amount of \$249,300 for Fiscal Year 2018. The purpose of the TCPP is to focus on building tribal capacity to implement culturally appropriate tobacco cessation and prevention initiatives that recognize the unique ceremonial uses of tobacco while reducing the use of commercial tobacco and its harmful effects. \$30,000 of the available funds were earmarked for tribal serving organizations. TCPP projects are closed out after one (1) year. The following entities were received appropriation/funding.

Special Projects - Closeouts

During the 2017 NM Legislative Session, IAD received General Fund Appropriations to support special projects in FY 2018 that benefit NM tribal communities. From this appropriation, the Department had \$201,000 available for Native American Language Preservation Programs and Native American Veterans Services. Special Project grant funding is not intended to be a permanent funding source for entities, but rather a short-term allocation. Special Projects are closed out after one (1) year. The following entities received funding in FY 2018.

New Mexico Finance Authority - NMSU Grants Campus

On July 6, 2018, the New Mexico Finance Authority Oversight Committee held a meeting in Grants, New Mexico. Acting Cabinet Secretary Suzette A. Shije co-presented with Jonas Armstrong, Capital Outlay Fiscal Analyst, Legislative Finance Committee and provided a report and update on the Tribal Infrastructure Fund Program. Acting Secretary Shije presented how many TIF applications were submitted and awarded, types of projects (planning, design and construction) and how many TIF projects were closed. Acting Secretary Shije provided an overview of the planning, design and construction performance period, components of how each application is reviewed based on critical need, readiness, capacity and leveraging, and based on addressing specific health, safety, welfare and economic needs. The presentation concluded with the fiscal year awards from FY 2012 to FY 2018 and success stories of infrastructure developments and completed projects in various communities of Ramah Chapter Waterline Extension, Red Rock Chapter Lagoon & Sewer Project, Mariano Lake Chapter Bathroom Additions and Zuni Pueblo Teen & Wellness Center. Mr. Armstrong presented the background information of the Tribal Infrastructure Fund, it's needs, the Board Application and Award Process, 2016 Revisions to the TIF Guidelines and Procedures, Award History and Project Progress and Spend Down Trends from FY2012 to FY2016.

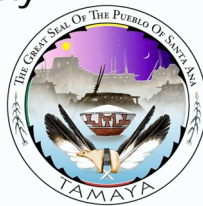
