- Project Update IAD has been working with the Tribes, Pueblos and Nation to close out projects and in this fiscal year 2018, twenty-five (25) Tribal Infrastructure Fund projects and forty-seven (47) Capital Outlay projects have been closed. We like to thank the grantees in working with IAD to have closed out a total of 72 successful projects.
- Special Projects Update In fiscal year 2018, Acting Secretary Shije has been working diligently with the grantees by conducting site visits and receiving status updates on special projects Language Preservation, Veterans Outreach Program, Tobacco Cessation and Prevention Projects.

Navajo Nation & NM Indian Affairs Department Reconciliation Meeting



History of the Bosque Redondo

The Bosque Redondo Memorial at Fort Sumner State Monument solemnly remembers the dark days of suffering from 1863 to 1868 when the U.S. Military persecuted and imprisoned 9,500 Navajo (the Diné) and 500 Mescalero Apache (the N'de) on a reservation known as Bosque Redondo at Fort Sumner, New Mexico— an area that encompassed 1,600 square miles (over one million acres).

The Bosque Redondo Memorial celebrates these two cultures' dignity, resilience, endurance, courage and strength, in the face of extreme hardship, isolation, sickness and death, to emerge from Bosque Redondo to become the admired and proud people they are today.

Navajo Nation - Hwéeldi/Bosque Redondo

On March 15, 2018, Acting Cabinet Secretary Suzette A. Shije and Lawrence John, TIF Administrator, attended the 150th Anniversary of the Hweeldi/Bosque Redondo Memorial meeting in Fort Sumner, New Mexico. The meeting discussed events that will take place commemorating the Long Walk of the Navajo people and the signing of the 1868 Treaty. Attendees were provided a site visit of where the original fort was located and where the treaty was signed between the Navajo leaders and U.S. Government, and where the Navajo's were held in captivity.





Navajo Nation - Hwéeldi/Bosque Redondo - SAVE THE DATE: JUNE 8-9,2018

In partnership with the Navajo Nation and the Mescalero Apache Tribe, the New Mexico Department of Cultural Affairs (DCA) is hosting several events to commemorate 150 years since the signing of the Treaty of 1868 between the United States government and the Navajo Nation at Fort Sumner Historic Site/Bosque Redondo Memorial.


June 8, 2018

DCA reveals a sneak peak of the upcoming permanent exhibits at the Bosque Redondo memorial, created by DCA and its partners. Visitors will have the opportunity to view the exhibit and offer feedback until 5:00 pm. Native artisans will be onsite, selling traditional foods, jewelry and weavings throughout the day. Free admission

June 9, 2018

DCA hosts several speakers and cultural dances from the Navajo Nation, the Mescalero Apache Tribe, and New Mexico state Government. Following ceremonies, patrons are invited to participate in a 7 mile walk from the Bosque Redondo Memorial to Fort Sumner High School in honor of the Navajo ancestors who returned to their homeland after signing the Treaty of 1868. Free admission.
